

GOLD HILL CITY COUNCIL COUNCIL MEETING MINUTES January 07, 2019

Due to the lack of a quorum, CM Lowe announced a change in procedure.

Mayor Newport swore in Councilor Wilson and Councilor Hinkley and Councilor Palmer who took their seats.

There were no Agenda adjustments

Meeting was called to order at 6:10 pm by Mayor Newport. Councilors Dell, Silva and West were marked absent. Councilor Studebaker has not yet been sworn in.

1. Appearance;

1.1 Joshua Loomis - 'Youth for Christ' organization Spoke briefly to introduce himself. He has been the host of the youth center for 5 months, The center exists to provide a safe, loving place for youth after schools. Youth clubs are open from 3pm to 6pm. Councilor Palmer asked about their hours of operation. Gold Hill is one of many other aspects of their Ministry ("Campus Life" is another)

2. Consent Agenda:

- **2.1 Approve Council Minutes, December 03, 2018** Councilor Palmer made motion to approve, was seconded by Councilor West. Motion was approved.
- **2.2** Approve Accounts Payable December 2018 Motion was made by Councilor Palmer, seconded by Councilor West. Councilor Palmer inquired about the \$30,000 monthly invoice from RVSS. Mayor Newport asked about reviewing paperwork before the checks are mailed. CM agreed to advise Mayor when AP checks are signed. Motion passes. Councilor West arrived.

3. Old Business:

3.1 2nd reading of update to Resolution 13-R-17 CM Lowe explained the basis of this issue; being the City workers compensation policy from CIS. We were NOT covering non-public safety volunteers such as a Councilor who volunteers to cover city hall. The Resolution was read at the December meeting; this is the required second reading. Councilor Hinkley discussed other volunteers

doing work for the city. Mayor Newport read the Resolution by title. Councilor Palmer made a motion to pass the Resolution seconded by Councilor Wilson.

3.2 Financial Officer Status report CM Lowe explained that former Mayor Stanley requested these two summaries. Councilor West inquired as to the status of outstanding audits. CM explained a meeting is being setup with all accounting personnel. Mayor Newport provided further details.

- **5.2 Update on WWFP CM** Plan is in regulatory phase...DEQ studying it. Plan is to hold multiple meetings with experts in the field. Plan is available from the CM. Councilor Hinkley asked if

there will be public hearings? Councilor Alford questioned how many options will be available to the city?

- **5.3 Homelessness/city ordinances (9.24.010) CM** Council was invited to review an article provided by CIS. Councilor West discussed her concerns. Gold Hill does not ticket or arrest anyone for camping violations. JCSO does enforce our anti-camping ordinance.
- **5.4 Public Works staffing CM** CM is recruiting to fill a vacancy for a Utility Worker/Operator. Will work with our personnel committee once applicants are selected. A meeting was set for Wed 01/09 at 9:00am.
- **5.5 Review 2018 CIS policy manual template CM** Same as above, CIS has asked that we review, customize and adopt a new version of their manual template. CM will provide our personnel committee with copies for their review.
- **5.6 Water Master plan status; funds for Seismic details.** An amendment to our Water Master plan is being completed by Civil West. The State has ordered a full seismic review done on ANY infrastructure projects. To cover the cost of that analysis, the State offered grant funds to offset some expenses. CM received grant funds of \$20,000 from business Oregon.
- 5.7 Communications with our residents; newsletter, possible reader board and city website. Councilor Hinkley is redesigning the city website; CM is writing a newsletter to residents monthly. Resident Margaret Dials discussed CanDO efforts to purchase a reader board for the city. Councilor Hinkley gave a report on the status of the city website.
- **5.8 Storm sewer update** Public Works is repairing the storm sewers in the neighborhood of first avenue and Chavner street. This area floods badly, and needs attention. Councilor West inquired about filtering the water flowing towards the river
- **5.9 JCSO status** .CM gave brief status of the current contract. The lead deputy wants to appear before Council in the future. The city does not operate any Neighborhood watch programs.

Public Input: Mayor Newport suggested that "Public input" be moved to the beginning of the meeting so individuals do not have to sit through the Agenda.

Resident Lorraine Parks spoke, informing us that the City Museum is closing for several months due to a lack of volunteers. She asks the City to support the Historical Society

Steve Keisling spoke as President of CanDo. They hope to collaborate with the city on civic improvement projects. Discussed development of hiking trails on Nugget Butte. July 13 is the date for the 2019 'King of the Rogue". Whitewater park representatives have met with State regulatory agencies, and there are no major blocks to development. City will be added to their email list.

Mayor Newport adjourned the meeting at 07:30 pm
